COVID-19 DAY / CLINIC CAMP RULES CAMP LOCATION (Updated 6.22.2020)

Safety is our priority for your camp experience. We are deeply committed to the safety and well-being of our athletes and coaches. We are prepared to deliver instruction that will meet the state and local guidelines related to COVID-19 at the time of the camp. While the final details and schedule of any camp could require up to the day adjustments, and all guidelines are subject to change based on Centers for Disease Control and Prevention ("CDC"), federal, state and local guidance, please be assured that Varsity Spirit is committed to delivering the same quality of instruction for which we are known. We appreciate your understanding of the flexibility this will require.

Below you will find the guidance that we believe is necessary for the camp location to follow in order to conduct a safe and enjoyable camp. In addition to this signed document, a copy of all additional guidelines established by the camp location must be provided to us prior to camp for them to be applied. We will need to work together to make sure that all guidelines are communicated, applied and enforced.

- Prior to hosting the camp, the facilities, including, restrooms, dining facilities and common areas, if applicable, shall be deep cleaned, disinfected, and sanitized in accordance with state and local guidelines.
- Maintain clean and sanitized facilities at all times during the camp in accordance with state and local guidelines. Frequently touched surfaces, such as door/sink handles, etc, must be sanitized with cleaners on the Environmental Protection Agency's list of disinfectants for use against SARS- CoV-2 as often as possible or as otherwise directed by state and local guidance, the CDC or as may be reasonably necessary.
- The camp location should be large enough for camp attendees to follow CDC, state and local guidelines. The CDC recommends maintaining 6 feet of distance from others. This translates into a 28 square-foot (i.e., a circular area with a 3-foot radius surrounding each person) allotment per person. To the extent feasible, outdoor facilities should be used and indoor facilities should be as well ventilated as possible. Indoor waiting areas and communal spaces, such as lobbies and common areas of athletic facilities, should be closed if required by state and local guidance. To the extent closure of communal spaces such as dining halls is not possible, use should be staggered and the space should be cleaned and disinfected between each use with EPA-registered disinfectants.
- Provide access to restroom facilities with proper sanitation areas for frequent handwashing. Must be properly equipped with hand sanitizer, soap, paper towels, trash can by exit, etc. Remove or prop open doors or other high touch points for entry/exit (if feasible). Provide hand sanitizer if required by state or local guidelines.
- Provide access to a separate holding room that campers can go to if feeling ill or present with signs/symptoms consistent with COVID-19. Any campers displaying symptoms of COVID-19 should be isolated until the camper's parent or guardian can arrive to pick up the camper. The separate holding room should be closed off during use and not used again until such area is cleaned and disinfected.
- Camp location staff must be available at all times during camp and available to assist Varsity Spirit staff, coaches and school administrators in enforcement of the established rules. Where possible, the camp location should have a designated employee that is wholly or partially dedicated to ensuring the health protocols prescribed by state and local guidance are followed.
- If any modifications or supplements are made to these guidelines prior to the start of camp, the camp location will follow the guidance set forth therein.
- Unless state or local governmental guidance expressly provides otherwise, each camp location employee or contractor will (i) provide their own face mask or face covering and other PPE and (ii) will wear a face mask or face covering at all times.
- Ensure that all staff and contractors employed by the camp location are screened for COVID-19 if and as required by state or local laws or guidance.
- Signage promoting proper hygiene and social distancing requirements should be placed conspicuously throughout the camp location, if required by state or local guidance.
